BYLAW 97/2011

A BYLAW PERMITTING THE USE OF ALL TERRAIN VEHICLES IN THE RESORT VILLAGE OF CHITEK LAKE

The Council of the Resort Village of Chitek Lake in the Province of Saskatchewan enacts to adopt a bylaw to permit the use of all terrain vehicles in the Resort Village of Chitek Lake as follows:

Interpretation

1. In this bylaw:

- a) "all terrain vehicle" means a self-propelled vehicle that:
 - i) Is designed primarily for the movement of people or goods on unprepared surfaces; and
 - ii) Has wheels in contact with the ground;

And includes:

- iii) A restricted use motorcycle;
- iv) A mini-bike; and
- v) An all terrain cycle;

But does not include:

- vi) A golf cart;
- vii) A snowmobile as defined in *The Snowmobile Act*;
- viii) An agricultural implement or special mobile machine as defined in *The Traffic Safety Act*; or
- ix) Any vehicle that is required to be registered pursuant to *The Traffic Safety Act*;

- 2. Each operator who operates the all terrain vehicle on the travelled portion of a road must hold a driver's license in pursuant to *The Traffic Safety Act*.
- 3. When the all terrain vehicle operator come to a highway as defined in *The Traffic Safety Act*, they must come to a complete stop and look in both directions before proceeding across.
- 4. All terrain vehicles while driving in the Resort Village of Chitek Lake must be driven in a safe and courteous manner.
- 5. A person who is guilty of an offence against this Bylaw is liable on summary conviction to a fine of not more than \$1000 and in default of payment to imprisonment for a term of not more than 30 days pursuant to Section 32 of *The All Terrain Vehicle Act*.

6. No person shall operate an all terrain vehicle on:

- a. A highway, whether travel or untraveled portion of it;
- b. Any public land;

unless there is, in respect of the operation of the all terrain vehicle, a subsisting contract of automobile insurance within the meaning of Part VI of *The Saskatchewan Insurance Act* insuring the owner and every person who operates the vehicle in an amount less than the prescribed amount against liability imposed by law on the insured named in the contract or that other person for loss or damage:

- (i) Resulting from the ownership, use or operation of the all terrain vehicle;
- (ii) Resulting from bodily injury to or death of any person, and damage to property.

7. Offenses:

Every person who:

- a. Contravenes any provision of this bylaw or the regulations; or
- b. Fails to comply with any provision of this Act or the regulations; is guilty of an offense against this bylaw.

Every person who authorizes or permits another person to operate an all terrain vehicle:

- c. In contravention of any provision of this bylaw or the regulations; or
- d. Without complying with any provision of this bylaw or the regulations; is guilty of an offense against this bylaw.


8. Penalty

- a. A person who is guilty of an offense against this bylaw is liable on summary conviction to a fine of not more than \$1000 and in default of the payment to imprisonment for a term of not more than 30 days.

9. This Bylaw is subject to *The All Terrain Vehicle Act*.

10. Bylaw 16/88 is hereby repealed.
