

**RESORT VILLAGE OF CHITEK LAKE  
BYLAW 136/2018**

**A Bylaw of the Resort Village of Chitek Lake to amend Bylaw 48/03 known as the bylaw to Regulate  
the Operation of Vehicles**

NOW, THEREFORE the Council of the Resort Village of Chitek Lake in the Province of Saskatchewan enacts to Amend Appendices 1, 9, and 12 of Bylaw 48/03 and to Create Appendices 13 and 14 as follows:

1. APPENDIX 1 OF BYLAW 48/03 Stop Streets [Section 2(a)] is amended to:
  - a. Chitek Drive where intersected by Pine Street
  - b. Cueleneare Crescent where intersected by Chitek Drive
  - c. Chitek Drive where intersected by Cueleneare Crescent
  - d. Third Avenue where intersected by Chitek Drive
  - e. Third Avenue where intersected to Pine Street
  - f. Vandale Avenue where intersected by Pine Street
  - g. Railway Street where intersected by Old Highway
  - h. Old Highway where intersected by Railway Street
  
2. APPENDIX 9 OF BYLAW 48/03 No Parking [Section 3(e)(4)] is amended to:
  - a. North side of Lakeshore Drive opposite angle parking lot
  - b. Lake Shore Drive, no parking between signs adjacent to beach and playground area
  - c. Pine Street, no parking between signs adjacent to Lot 1, Block F
  - d. Pelican Beach by change rooms at any time
  - e. Hillside Park at any time
  - f. Overnight at the Chitek Lake Community Hall
  - g. Overnight at Tyndall Park
  - h. Overnight at the Boat Launch
  - i. Boat Launch parking reserved for vehicles with boat trailers attached only
  
3. APPENDIX 12 OF BYLAW 48/03 Where Provincial Highway 24 crosses is amended to:  
Where Provincial Highway 24 crosses:
  - a. Helen Street
  - b. Third Avenue
  - c. Second Avenue
  - d. First Avenue
  - e. Chitek Drive
  - f. North Shore Road
  - g. Vandale Avenue

4. To Add APPENDIX 13 Under the PARKS REGULATION ACT and subject to Section 28(1):
  - a. It is unlawful to launch a motor boat or any other water vessel in ANY area other than a designated area
  
5. This bylaw shall come into effect on the date of approval of the Saskatchewan Highway Traffic Board.
