

RESORT VILLAGE OF CHITEK LAKE
BYLAW NUMBER 37, 2000

A bylaw of the Resort Village of Chitek Lake to provide for a permanent closure of an Avenue.

WHEREAS Section 11 of the Highways & Transportation Act, 1997, provides for the closure of any road or walk-way vested in the Crown, subject to the consent of the Minister of Highways & Transportation, and following Public Notice of the proposed closures;

AND WHEREAS Section 156 of the Urban Municipality Act, provides that Public Streets and Walkways are subject to the direction, control and management of the Municipality;

AND WHEREAS the Minister of Highways & Transportation has consented to and Council has given the required Public Notice of the proposed closure;

THEREFORE the Council for the Resort Village of Chitek Lake, in the province of Saskatchewan, ENACTS:

- (1) To permanently close all of First Avenue, Registered Plan Number 77B04148, Chitek Lake, Saskatchewan.
- (2) THAT the Minister undertakes such other things to effect the intent of this Bylaw.
- (3) Will come into effect upon approval of the Minister.

The Petition of Council for the Resort Village of Chitek Lake, in the province of Saskatchewan, Dominion of Canada, SHOWETH:

- (1) THAT Her Majesty the Queen (Saskatchewan), c/o The Department of Highways & Transportation, is the vested owner of all of the following:
"ALL of First Avenue, Registered Plan Number 77B04148, Chitek Lake, Saskatchewan."
- (2) THAT the Resort Village of Chitek Lake is desirous of canceling the said Avenue in order to effect a new plan of subdivision.
- (3) THAT produced herewith is one certified copy of Bylaw Number 37,2000, of the Council for the Resort Village of Chitek Lake.
- (4) THAT produced herewith is the consent of Saskatchewan Power Corporation, SaskEnergy, SaskTel and the Department of Highways & Transportation, to the said cancellation.

WHEREAS your Petitioner prays that the Master of Titles do issue an Order directing:

- (1) THAT the above plan numbered 77B04148, be amended with respect to the above described Avenue.
- (2) THAT a new Certificate of Title be issued in the name of: "The Resort Village of Chitek Lake, Box 70, CHITEK LAKE, Saskatchewan, S0J 0L0".
- (3) THAT such other things be done that the Master of Titles deems necessary.
